ARE SMART TV'S TOO SMART?

[Courtesy: Denver District Attorney's Office] As wonderful as it is to watch your favorite shows on a Smart TV, that Smart TV is also watching you. The FBI has addressed the question many people have asked: **Can hackers get in to Smart TVs? The simple answer is YES.**

In order for your Smart TV to be, well, smart, it needs to learn your viewing habits which is sent to programming services (like YouTube and Netflix). That information allows the programmers to push relevant program choices to you. And, as with any internet-connected device, if it's connected, (Smart TVs are), it's hack-able.

Hackers probably don't care about what you're watching, but they do like to get every piece of information about you in any way they can. Remember, not only are Smart TVs connected to your internet, many have microphones and cameras. A trifecta for hackers!

Hackers can watch you, hear you and if they are good enough, they can get to your other internet-connected devices. Think about it, if programming services can collect your viewing habits, which they do, hackers can collect information as well. If your TV is unsecured, a hacker has the ability to take control and possibly do real damage.

AND ... ALEXA IS ALSO LISTENING!

If the thought of Amazon employees listening to your chats with Alexa is too unsettling, here's how you can disable that function by following seven quick steps:

- 1. Open the Alexa app on your phone.
- 2. Tap the menu button on the top left of the screen.
- 3. Select "Alexa Account."
- 4. Choose "Alexa Privacy."
- 5. Select "Manage how your data improves Alexa."
- 6. Turn off the button next to "Help Develop New Features."
- 7. Turn off the button next to your name under "Use Messages to Improve Transcriptions."

LOOK FOR YOUR INVITATION TO BE COUNTED IN THE 2020 CENSUS

It's in the Constitution: Article 1, Section 2, mandates that the country conduct a count of its population once every 10 years. The 2020 Census will mark the 24th time that the country has counted its population since 1790.

The census provides critical data that lawmakers, business owners, teachers, and many others use to provide daily services, products, and support for you and your community. Every year, billions of dollars in federal funding go to hospitals, fire departments, schools, roads, and other resources based on census data.

The results of the census also determine the number of seats each state will have in the U.S. House of Representatives, and they are used to draw congressional and state legislative districts.

The count is conducted by the U.S. Census Bureau, a nonpartisan government agency. The 2020 Census counts the population in all 50 states, the District of Columbia, and five U.S. territories (Puerto Rico, American Samoa, the Commonwealth of the Northern Mariana Islands, Guam, and the U.S. Virgin Islands). Each home will receive an invitation to respond to a short questionnaire—online, by phone, or by mail.

Invitations to respond to the 2020 Census will be delivered between March 12-20. Once you receive that invitation, you can respond online, by phone, or by mail.

ZONING & PLANNING COMMITTEE

JOIN THE WDCA ZONING & PLANNING COMMITTEE (WDCA ZAP)

Winston Downs Community Association/WDCA is a Registered Neighborhood Organization (RNO) that, by city ordinance, receives an official notice when a property owner wants an exception or variance from the **zoning** code.

Also, by city ordinance, the Department of Excise and License notifies neighborhood associations (RNO) of applications for, or modifications of, **liquor and marijuana** retail licenses. There are a variety of types of liquor licenses (tavern, cabaret, restaurant, retail sales, etc.) each with separate rules and regulations. Marijuana licenses include grow-facilities, retail sales and medical dispensaries.

WDCA ZONING COMMITTEE PURPOSE

- The Zoning and Planning (ZAP) Committee works with the City of Denver on regulations and development of private properties (residential as well as commercial) in the context of our neighborhood's concerns.
- WDCA ZAP responds to development items that are up for public comment. These include builders seeking design variances, developers seeking re-zoning of properties, as well as landmark and historic designations.
- Other projects might include the development of a Design Overlay addition to the Denver Zoning Code; reviewing the status of public area; and contributing useful information to the WD newsletter.

WHO SERVES ON THIS COMMITTEE

Residents and property owners within Winston Downs and Lee Downs may become committee members. The Board appoints the chair of the committee.

ZAP members will be tasked with researching and presenting recommendations for the WDCA Board to consider. Recent issues that are examples of the type of issue that we would seek support from the ZAP committee members include:

- Conservation Overlay discovery of interest
- 400 S. Monaco Pkwy Historic designation and farmhouse being demolished and lot sold
- 716 S. Poplar St City sale of former half-way house to a non-profit operator of homes for physically and intellectually disabled
- Fairmount Cemetery application for liquor and cabaret dance license in 2018

STAY AT HOME PUBLIC HEALTH ORDER

As most of you know, the Stay at Home Public Health Order runs through April 10, at least. We offer this information so that WD residents know what the rules mean.

- WD residents may not gather in groups on public OR private property. You are considered to be "gathering in a group" if you are within six feet of anyone you do not share a residence with. Group gatherings are prohibited in City of Denver Parks, the green spaces between or in front of your home - anywhere outside of your residence whether on public OR private property.
- City of Denver Parks remain open for walking, hiking, biking, running, and similar activities, provided individuals comply with social distancing requirements (6+ feet).
- Park amenities, including playgrounds and picnic areas, are closed and must not be used.
- City staff park rangers, safety officers, and public health officials - will be patrolling and educating the public and, if necessary, issuing citations and fines of up to \$999.

Any concerns about violations of the Stay at Home Public Health Order should be reported to the City of Denver via 311 or the District 3 Police Department **Non-Emergency Line** at (720) 913-1300.
