# **Zoning Report - Jackie**

Cottonwood Community Facility - 716 S Poplar – Sale Finalized and Sold

\*Jackie spoke with Cottonwood about the home in our neighborhood. They seemed honest, sincere and willing to share and be good neighbors.

\*Their focus is 1. Care for residents 2. Live & Thrive

\*They plan to only have 3 full time residences at one time along with 1 staff member.

\*The residences range in abilities from independent/ working to some that need 24/7 care. The residences have not at this time been determined.

\*The staff member will have a car and is allowed to leave to for short times to run errands.

\*They are concentrating on making interior repairs, then will do exterior repairs.

\*David Howlett mentioned that at one time they were planning on spending about \$300K - \$350K for renovations.

\*Tim: Wondered if effected neighbors will get notified of the information and who will be living in the house.

\*Logan: Assumes it would be a public zoning notice and will find out for sure to let us know.

# **Crime Report: By Margot**

\* "Crime Spot" states what is going on in our neighborhood

\* Leetsdale area has reported more assaults as of lately, mostly due to domestic violence

\*Car thefts rising – most popular stolen cars are Kias. Remember to keep car doors locked and not to leave valuables in the car

\*Spoke to police commander and he felt that our neighborhood/small pocket of homes has a lower crime rate than most areas in the city. Jan/Feb had extremely low crimes, but we should stay alert and be aware as the weather warms up.
