Winston Downs Community Association Board of Directors Meeting

Meeting Minutes – January 18, 2022 Meeting held via Zoom

Board Members in Attendance: Jane Lorimer, Brandon Harrelson, Marsha Badanes, Joanna Milewski, Tim Rooney, Margot Gilbert Frank

Approval of Minutes; Motion made by Marsha and seconded by Joanna to approve December 15, 2021 minutes. Vote to approve was unanimous.

President's report- Jane

- 440 S Monaco has approval for change of use to religious assembly. They are upgrading to meet certificate of occupancy requirements.
- 660 S Monaco went to auction and was not purchased so it reverted back to the bank. It is likely the bank will sell to a developer.
- 333 S Oneida Way permit to change use is still in process. They will also be required to meet certificate of occupancy requirements if granted
- 6750 E Exposition Owners are advertising the home for short term rentals (i.e. Airbnb) which is a
 permitted use. If there is a separate locked entry to the addition, then it violates ADU zoning
 requirements because 1) ADUs are not permitted in Winston Downs and 2) Owners did not file for
 rezoning
- Newsletter went out this week. We paid to have it stuffed and delivered this time due to Covid

Treasury report- Joanna: The WDCA account balances as of December 31, 2021 were:

- Savings: \$7,009.00, Checking: \$2,893.84 for total of \$9902.84
- Big expenses were newsletter printing and delivery at about \$550

Budget: The Board considered the proposed budget (see attached). A motion was made by Marsha to approve the budget with added funding for welcome bags. It was seconded by Brandon and the budget was approved unanimously. Discussion on need to sell advertising to offset the cost of printing and delivering newsletter.

Planning and Zoning: Residents in attendance expressed ongoing concern about the traffic, pedestrian safety and other various issues related to the change of use of the property at 333 S Oneida Way from single-family residential to religious assembly. Residents with neighboring fence damage made by 333 reported they have yet to file claims for reimbursement for repairs and were urged to do so.

The Board proposed to organize a committee to outline what the content of a good neighbor agreement or memorandum of understanding between WDCA and major change of use properties in Winston Downs might be. (Note: GNA was offered by the group requesting change of use at Nov 16 presentation.)

A motion was made by Margot to approve an ad hoc committee for this purpose. The motion was seconded by Joanna and approved unanimously. A number of residents volunteered to participate in the ad hoc committee including Jackie Robb, Susan Greene, Katy Trinkley and Margot Gilbert Frank. Marsha Badanes will head up the committee.
